Q: On #1, how many days/weeks should stock be trading higher?

A: Just on the "Surprise" day we want to see trading higher on the news

Audience Question

Q: All good. How closely do you pay attention to bid/ask spread. And open interest?

A: We always check the bid/ask spread to make sure it is manageable. Open Interest isn't a huge concern since we usually are only trading a few contracts to maybe 10 or 20 for most positions. So as long as the bid/ask isn't too out of control we can roll with it. Also, if the equity has weekly options it is most likely actively traded

Q: Thank you: "Just on 'Surprise' day"... but higher than that day's opening or previous day's close?

A: Good question, to clarify, yes we want it to be trading higher than the previous day's close. Showing us the stock is moving higher

A: It isn't necessarily a key factor, but we do like if the 100 is above the 200 SMA... just shows us it hasn't dropped too much

#### Audience Question

Q: I want to join the WOW group if it is feasible to make 10% a month on a 25K account doing the money presses and other techniques of Preston. Is this possible?

A: We see WOW Insiders make those types of returns for sure, sometimes even more. But of course nothing is guaranteed in trading. You will hit months like Sept that are more of a battle, but overall the market is more likely to go up or sideways where the Money Press can produce really exciting gains.
